15. Multidisciplinary / interdisciplinary

The teaching learning pedagogy adopted in this institution ensures amalgamation of intellectual, scientific, emotional, social and cultural development among its students. Apart from the regular credit-based courses, Students are also allowed to select elective papers from any discipline of their choice Academic programmes are redesigned to include Multidisciplinary /Interdisciplinary courses as electives. Some of the Multi-Disciplinary Courses are Digital electronics and Microprocessor, Fibre Optic Communication, Mathematical Physics, NanoPhysics, Microbial Quality Control testing, Microbial Bio technology, Marine Biology, Accounting and Financial Management, Organization Behaviour, Human Resource Management, Public Finance, Women Studies, Computer Applications in management, Mathematics and Statistics for Managers, Operation Research etc.

Inter Disciplinary Courses are Page maker, Computer systems and Networks, PythonProgramming, SoftwareEngineering, Women's Health and Nutrition, MaterialScience, QuantumMechanics, Solid State Physics, Aqua culture, Sericulture, Microbial Bio Chemstry, Probability and Statistics, Hardware and system Assembly, Mathematics for Economics, Computer Applications in Economics, Managerial Economics, Managerial Communication, Advertising and Sales Promotion, Derivatives Management, Consumer Behaviour, International Relations Management, Production Management etc.

29 value—added courses are being offered to students i.e. Transform Your Life with Meditation, English for Bpo, Principles of Event Management, Artificial Intelligence and its Application in Business, Basics of Solar Energy, Tailoring etc. All programmes are designed in such a way that students get maximum flexibility to choose elective courses offered by other Departments . Seminars/workshops/ training programs have been introduced which enables the integration of humanities and science. Social service activities mediated by NSS, NCC, relevant clubs and committees in the college play a pivotal role in sensitizing students towards environmental, social and health issues. The institution is looking forward to offer a multidisciplinary flexible curriculum in upcoming years.

Collaborative research projects involving staff, students from different departments are being undertaken to address the issues and challenges faced by the society. These initiatives foster the capacity building of the youth into responsible citizens.

16.Academic bank of credits (ABC):

Our Parent University has not yet implemented the Academic Bank Credit. So we are not having any plans of implementing this Academic Bank Credits at present.

17.Skill development:

The institution has made enormous efforts to strengthen the vocational education and soft skills of students. We are offering the skill development and value added courses already in our curriculam. Softskill development cell has been functioning in our institution. Through this cell programmes have been organized to develop the soft skill of the students. Some of the Programmes are Emerging trends and challenges for the communication skills in 21st Century

The institution is also providing value based education to the students Value based education courses were included in the curriculum. They are Value Education, Environmental Studies, Softskill development, Gender studies and Managerial Skills and also the institution creates ethical values in the minds of the students by celebrating all the national days and national leaders birth and death anniversaries in a grand manner.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Tamil is being taught as Part I in the regular curriculum. The Fine Arts Association of the college is providing trainings to students in Indian Arts, dance, music and culture to preserve and promote our traditions. Special courses are offered to students on Indian Herbal Medicines. Yoga trainings and meditation sessions are given to our students.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

Outcome-Based Education (OBE) is a pedagogical model that entails the restructuring of curriculum, pedagogy and assessment practices to reflect the achievement of high-order learning, as opposed to a mere accumulation of course credits. While the traditional education system focuses on what is taught, OBE places emphasis on what is

learned, which is a student-centric model. IQAC organized multiple faculty development programmes on Outcome based Education (OBE) All the faculties of the college were trained in OBE. Based on the training, all courses were designed under OBE paradigm with Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes (CO) specified. The curriculum clearly states Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes (CO) and teaching-learning pedagogy adapted at the institute. Assessment tools are designed considering the requirements of POs, PSOs and COs. The activities and programs are organized in the Institute to achieve POs, PSOs and COs. At the end of the semester, analysis of PO, PSO, CO attainments is done by each department. The outcomes have been articulated in the college website. Every faculty explains the course outcomes of each course before the commencement of the same. To integrate OBE all the faculty members are advised to prepare Question Banks based on bloom's taxonomy. It enables the assessment of the students at cognitive levels namely remembering, understanding, applying, analyzing, evaluating and creating.

20.Distance education/online education:

During pandemic, the system has adopted the change from classroom teaching to blended learning. Google drive, Google classrooms are effectively used for course conduction and evaluation process. Each course contents are available on Goggle classroom including syllabus, PPTs and notes. The assessments of the courses are done through online assignments, quizzes. The MCQ tests are conducted using Google platform. Online sessions are conducted and recorded on Google meet. Various student activities are conducted online using Google meet.

Online education provides ample flexibility to students to learn and explore as per their requirements at their pace. It proved to be a versatile tool particularly during the Covid pandemic as it enabled conduct of online classes, management of attendance, submission of assignments, webinars, training programs, fine arts festival and even commemorate important days and events. During the pandemic, most of the classes were conducted online and faculty members and students have gained experience on working with digital tools such as OBS (Open Broadcaster Software), Google Tools, Online
Whiteboards, YouTube to develop and deliver e-content, short videos, interactive power point presentations and other online content. With offline classes being pursued at present, the faculty and students at the institute are looking forward towards blended learning as it integrates the learning experience with a humane aspect. Therefore, the students can gain from the benefit of online teaching along with

face-to-face interaction with their mentors. Students are also encouraged to engage in courses offered by online portals such as Swayam, Courses etc. to widen their sphere of knowledge and understanding and sharpen their skills. The college is an active Local Chapter of NPTEL courses.

The Curriculum of our Institution is systematically planned and designed by keeping the vision and mission of the Institution to provide higher education to the women students of the rural and economically weaker sections of the society. Our Institution adopted Choice Based Credit System (CBCS) from 2005 onwards for all its programmes. Every programme presents programme outcomes, programme specific outcomes, and carries course outcomes of each course. For PG programmes, the programme outcomes generally are mastery of the subject knowledge, Critical Thinking and Problem Solving, Research related skills and so on. For UG programmes, the programme outcomes can be understanding the course/subject concepts, learning effective communication skills in English and one or more Indian languages, and relationship between self and the community. General course structure is prepared under the guidelines of UGC, TANSCHE and Parent University. Based on the needs of the stakeholders, new courses relevance to the local, national, regional and global level has been introduced and these courses are framed to match with the POs and PSOs of the respective programme. The syllabi are discussed with the HoDs and Faculties, Subject Experts, Special Invitees, Industrial Expert, and Alumna in the Board of Studies and implemented after approval of the Academic Council and Governing Body. The Syllabus and mapping of PO, PSO and CO are displayed in the Institutional website.

Teachers reach out to the students through various technological media and channels. The college has its own Learning Management System (LMS). It provides facility of 'Anytime learning'. The learners can see lecture recordings, videos, presentations, notes, join forums for discussions and debates; and can even upload their assignments, projects in this system. Other platforms being used are google classroom, Microsoft Teams, facebook live, google groups, Open Broadcaster Software (OBS) and youtube live for academic activities and online teaching. Learning modules, ebooks and virtual labs are also made available. Institutional Group SMS and Clobas ERP App are used for communicating academic matters. Teachers of our college have developed over 79 e-contents.

7.1.3 - Describe the facilities in the institution for the management of the following types of degradable and non-degradable waste (within a maximum of 200 words)

The bio degradable wastes such as plant litters, old newspapers, papers, card boards are transported separately to the composting yard, and transformed into organic manures by Vermicomposting and used for gardening. A project on biotransformation of lignocellulosic wastes into organic manure is undertaken as a continuous process. The vegetable wastes and the food wastes generated are collected separately and subjected to composting unit. The non bio-degradable wastes such as tin, glass, plastics, are sold to venders dealing with recycling. The sanitary napkins, and the cottons used in the laboratories are made into ash by using incinerators.

The waste water generated in the hostel is treated and used for the purpose of Irrigation of coconut farms.

The biologically contaminated waste materials such as media and microbial culture are sterilized using autoclave, disinfected and disposed in proper labeled disposable bags and disposed in pits and incinerated.

The outdated computers are exchanged at the time of upgradation. Other types of e-wastes are collected, stored and disposed off through agencies /vendors.

Waste water and Grey water are collected and treated using recycling plant.

The chemicals used in the chemistry laboratory are disposed after dilution, collected in choke pitsand released. Acids are neutralized and released.

7.1.3 - Describe the facilities in the institution for the management of the following types of degradable and non-degradable waste (within a maximum of 200 words)

The bio degradable wastes such as plant litters, old newspapers, papers, card boards are transported separately to the composting yard, and transformed into organic manures by Vermicomposting and used for gardening. A project on biotransformation of lignocellulosic wastes into organic manure is undertaken as a

continuous process. The vegetable wastes and the food wastes generated are collected separately and subjected to composting unit. The non bio-degradable wastes such as tin, glass, plastics, are sold to venders dealing with recycling. The sanitary napkins, and the cottons used in the laboratories are made into ash by using incinerators.

The waste water generated in the hostel is treated and used for the purpose of Irrigation of coconut farms.

The biologically contaminated waste materials such as media and microbial culture are sterilized using autoclave, disinfected and disposed in proper labeled disposable bags and disposed in pits and incinerated.

The outdated computers are exchanged at the time of upgradation. Other types of e-wastes are collected, stored and disposed off through agencies /vendors.

Waste water and Grey water are collected and treated using recycling plant.

The chemicals used in the chemistry laboratory are disposed after dilution, collected in choke pitsand released. Acids are neutralized and released.
