MULTI DISCIPLINARY/INTERDISCIPLINARY

The teaching learning pedagogy adopted in this institution ensures amalgamation of intellectual, scientific, emotional, social and cultural development among its students. Apart from the regular credit-based courses, Students are also allowed to select elective papers from any discipline of their choice Academic programmes are redesigned to include Multidisciplinary /Interdisciplinary courses as electives. Some of the Multi-Disciplinary Courses are Digital electronics and Microprocessor, Fibre Optic Communication, Mathematical Physics, Nano Physics, Microbial Quality Control testing, Microbial Bio technology, Marine Biology, Accounting and Financial Management, Organization Behaviour, Human Resource Management, Public Finance, Women Studies , Computer Applications in management, Mathematics and Statistics for Managers, Operation Research etc.

Inter Disciplinary Courses are Page maker, Computer systems and Networks, Python Programming, Software Engineering, Women's Health and Nutrition, Material Science, Quantum Mechanics, Solid State Physics, Aqua culture, Sericulture, Microbial Bio Chemstry, Probability and Statistics, Hardware and system Assembly, Mathematics for Economics, Computer Applications in Economics, Managerial Economics, Managerial Communication, Advertising and Sales Promotion, Derivatives Management, Consumer Behaviour, International Relations Management, Production Management etc.

Inter Disciplinary programmes B.Sc Biochemistry and M.Sc Biochemistryare conducted.Multi disciplinary courses were offered by the department of Nutrition and Dietetics, Business Administration and Computer Applications in their respective curriculam.

28 value-added courses are being offered to students i.e. Transform Your Life with Meditation, English for Bpo, Principles of Event Management, Artificial Intelligence and its Application in Business, Basics of Solar Energy, Tailoring etc. All

programmes are designed in such a way that students get maximum flexibility to choose elective courses offered by other Departments .Seminars/ workshops/ training programs have been introduced which enables the integration of humanities and science. Social service activities mediated by NSS, NCC, relevant clubs and committees in the college play a pivotal role in sensitizing students towards environmental, social and health issues. The institution is looking forward to offer a multidisciplinary flexible curriculum in upcoming years. Collaborative research projects involving staff, students from different departments are being undertaken to address the issues and challenges faced by the society. These initiatives foster the capacity building of the youth into responsible citizens.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The Choice Based Credit System offers greater academic flexibility for the students to choose their subjects of interest. LOCF is implemented for the Choice Based Credit System (CBCS) for the Undergraduate (UG) and Postgraduate (PG) programmes. It focuses on learning, rather than teaching with a student-centred approach. The number of training programmes, workshops, and internal deliberations for the faculty and involvement of employers, alumni and academic experts. help the institution to define the POs, PSOs and COs for respective programmes and courses. The courses are designed aesthetically and then periodically revised according to the changing advancements in the respective fields to make the students more competitive and industry- ready, once they graduate. IQAC organized multiple faculty development programmes on Outcome based Education (OBE) All the faculties of the college were trained in OBE. Based on the training, all courses were designed under OBE paradigm with Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes (CO) specified. The curriculum clearly states Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes (CO) and teaching-learning pedagogy adapted at the institute. Assessment tools are designed considering the requirements of POs, PSOs and COs. The activities and programs are organized in the Institute to achieve POs, PSOs and COs. At the end of the semester, analysis of PO, PSO, CO attainments is done by each department. The outcomes have been articulated in the college website. Every faculty explains the course outcomes of each course before the commencement of the same. To integrate OBE all the faculty members are advised to prepare Question Banks based on bloom's taxonomy. It enables the assessment of the students at cognitive levels namely emembering, understanding, applying, analyzing, evaluating and creating.

20.Distance education/online education:

Various online platforms are used for online seminars and assignments in order to facilitate participatory learning, Google Classroom is used by the teachers as well as the students to teach, create, share and evaluate assignments. Using websites like Canva and Adobe Spark, teachers create visually engaging presentations enhancing student concentration and focus. Students and teaching faculty can access study materials in all the

Upon completion of Part III courses, students gain solid knowledge of their core subject and two allied subjects. Part IV of the syllabus for UG students includes additional skills needed to excel in their main competitive exams. Ethical, social, environmental and gender issues are covered in the subjects of Part V. Upon successful completion of their course, students become socially responsible citizens with employable skills required in their core subject. By completing projects in master's programs, students develop their skills in planning, critical thinking, processing, analyzing ideas and techniques, and developing them to a useful conclusion. 2.5.3 - IT integration and reforms in the examination procedures and processes including Continuous Internal Assessment (CIA) have brought in considerable improvement in the Examination Management System (EMS) of the Institution

The IT integration has modernized the entire examination process. The appointment orders for examination related duties are issued through e-mail to the concerned faculty and examiners. Through the online mode the exam fees were collected. Results are published in the college website and ERP (CLOBAS). Color printed mark sheets with photograph of the students are printed on non-tearable teslin paper which has 13 security features. Examination procedure has been completely automated using COE automation software (eCOE5.0) which maintains student's records in an efficient manner. Semester pattern are implemented with CIA components (two centralized CIA examinations, three assignments, seminar presentation and attendance) for all courses. Students securing minimum 40% marks in CIA along with 75% attendance components are eligible to appear ESE. Students can apply for Transparency, Retotaling, and Revaluation. Viva-voce for final year students is conducted to

improve their confidence to face interview. Project work is made mandatory for all UG and PG students. The supplementary examination is conducted within thirty days from the publication of regular ESE results so as to complete the course within the study period for each semester. IT tools are effectively utilized for conducting examinations, evaluation and declaration of results.

The bio degradable wastes such as plant litters, old newspapers, paper card boards are transported separately to the composting yard, and transformed into organic manures by Vermicomposting and used for garden A project on biotransformation of lignocellulosic wastes into organic manure is undertaken as a continuous process. The vegetable wastes and food wastes generated are collected separately and subjected to compost unit.

The non bio-degradable wastes such as tin, glass, plastics, are send to venders dealing with recycling. The sanitary napkins, and the cotton used in the laboratories are made into ash by using incinerators. The waste water generated in the hostel is treated and used for the purpose of Irrigation of coconut farms.

The biologically contaminated waste materials such as media and microbial culture are sterilized using autoclave, disinfected and disposed in labeled disposable bags and disposed in pits and incinerated. The outdated computers are exchanged at the time of upgradation. Other types of e-wastes are collected, stored and disposed off through agent/vendors.

Waste water and Grey water are collected and treated using recycling pit.

The chemicals used in the chemistry laboratory are disposed after dilution collected in choke pits and released. Acids are neutralized and released
