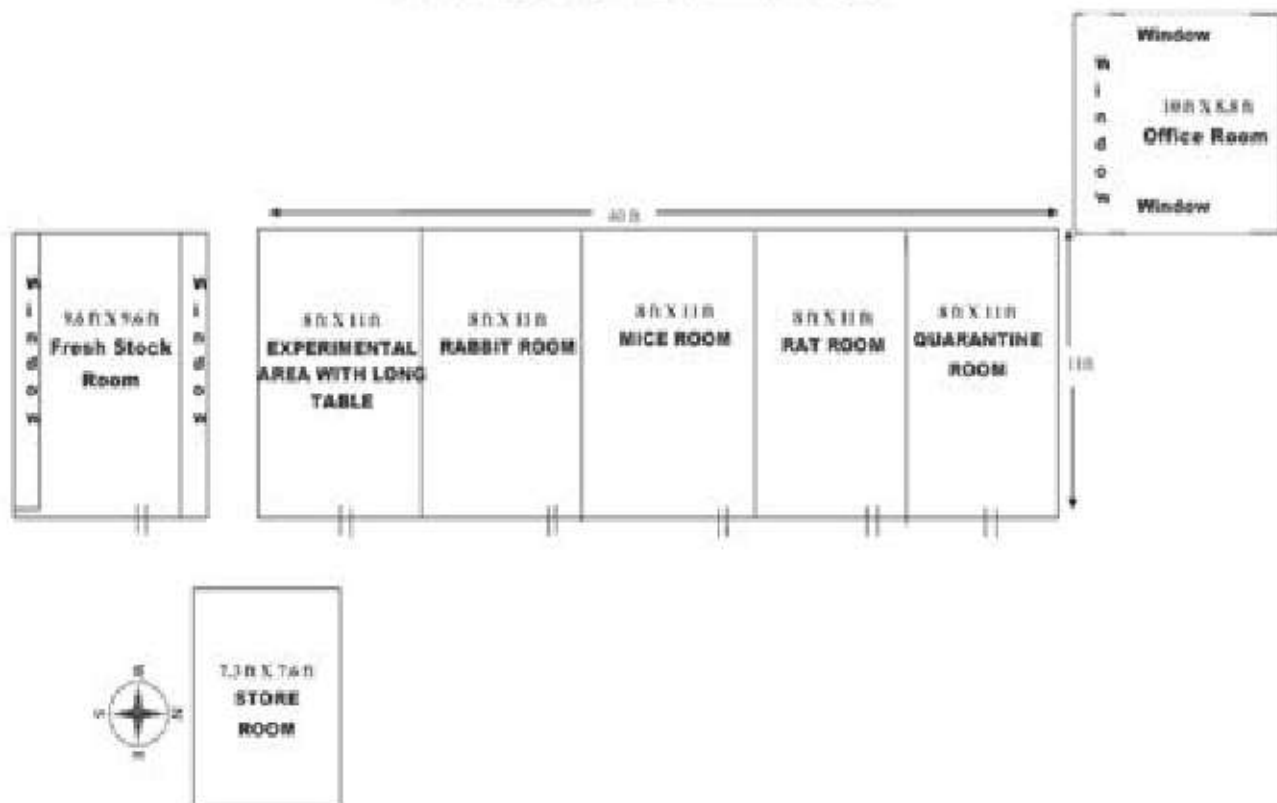







Item No 6: Revision of Appointment of Veterinarian
