15.Multidisciplinary / interdisciplinary

The teaching learning pedagogy adopted in this institution ensures amalgamation of intellectual, scientific, emotional, social and cultural development among its students. The vision of the college is to promote student's holistic development in both academic and non-academic spheres. The curriculum is designed as per the needs and feedbacks obtained from the various stakeholders. The insightful feedback from the students also helps in reshaping the curriculum. It is designed to ensure that students acquire the domain knowledge, skills and attitude. The outline of the course is carefully chosen for the students to take up various competitive exams. The curriculum structure has been designed to incorporate multidisciplinary education and a learner-centric approach. All undergraduate (UG) and postgraduate (PG) programs have been restructured to offer multidisciplinary options, and the curriculum has been revised to incorporate Outcome-Based Education. Undergraduate programs have been restructured with modified Learning Outcomes and Curriculum Frameworks (LOCF), including internships. Value Added Courses are offered to provide additional skills and knowledge beyond the boundaries of students' majors. The Value-Added Courses offers the flexibility of students, to choose the various multi-disciplinary courses which mould them to acquire overall personality development. Apart from the regular credit-based courses, Students are also allowed to select elective papers from any discipline of their choice Academic programmes are redesigned to include Multidisciplinary /Interdisciplinary courses as electives. Some of the Multi Disciplinary Courses are Digital electronics and Microprocessor, Fibre Optic Communication, Mathematical Physics, Nano Physics, Microbial Quality Control testing, Microbial Bio technology, Marine Biology, Accounting and Financial Management, Organization Behaviour, Human Resource Management, Public Finance, Women Studies , Computer Applications in management, Mathematics and Statistics for Managers, Operation Research etc. Inter Disciplinary Courses are Page maker, Computer systems and Networks, Python Programming, Software Engineering, Women's Health and Nutrition, Material Science, Quantum Mechanics, Solid State Physics, Aqua culture, Sericulture, Microbial Bio Chemstry, Probability and Statistics, Hardware and system Assembly, Mathematics for Economics, Computer Applications in Economics, Managerial Economics, Managerial Communication, Advertising and Sales Promotion, Derivatives Management, Consumer Behaviour, International Relations Management,

Production Management etc. Inter Disciplinary programmes B.Sc Biochemistry and M.Sc Biochemistry are conducted.Multi disciplinary courses were offered by the department of Nutrition and Dietetics, Business Administration and Computer Applications in their respective curriculam. 28 value-added courses are being offered to students i.e. Transform Your Life with Meditation, English for Bpo, Principles of Event Management, Artificial Intelligence and its Application in Business, Basics of Solar Energy, Tailoring etc. All programmes are designed in such a way that students get maximum flexibility to choose elective courses offered by other Departments .Seminars/ workshops/ training programs have been introduced which enables the integration of humanities and science. Social service activities mediated by NSS, NCC, relevant clubs and committees in the college play a pivotal role in sensitizing students towards environmental, social and health issues. Collaborative research projects involving staff, students from different departments are being undertaken to address the issues and challenges faced by the society. These initiatives foster the capacity building of the youth into responsible citizens.

16.Academic bank of credits (ABC):

We have started implementing Academic Bank of Credits (ABC).The college has well established academic bank of credits. The details of the credits earned by each student are digitally stored in the office of the controller of examination. Being an autonomous institution, the office of the controller of examination has upgraded software system to generate the mark statement of each student which contains the marks secured and the credits earned by the student in each semester and to generate the cumulative mark statement of each student which includes the percentage of marks, the cumulative grade point average (CGPA) and the weighted average marks obtained by the student. Also the mark sheet contains the register number and the photo of each student. We are in the process of uploading our students' Credit details in the ABC DigiLocker.

17.Skill development:

To promote skill based training on entrepreneurship and Innovation tailoring course was offered to the students as value added course. The curriculum offered by the college includes skill based elective papers to under graduate students which help the students to acquire skill in their core subjects. The institution made enormous efforts to strengthen the vocational education and soft skills of students. We are offering the skill development and value added courses already in our curriculam. Softskill development cell has been functioning in our institution. Through this cell programmes have been organized to develop the soft skill of the students. Some of the Programmes are Emerging trends and challenges for the communication skills in 21st Century The institution is also providing value based education to the students .Value based education courses were included in the curriculum. They are Value Education, Environmental Studies, Softskill development, Gender studies and Managerial Skills. And also the institution create ethical values in the minds of the students by celebrating all the national days and national leaders birth and death anniversaries in a grand manner

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Tamil is being taught as Part I in the regular curriculum. The Fine Arts Association of the college is providing trainings to students in Indian Arts, dance, music and culture to preserve and promote our traditions. Special courses are offered to students on Indian Herbal Medicines. Yoga trainings and meditation sessions are given to our students

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The Choice Based Credit System offers greater academic flexibility for the students to choose their subjects of interest. LOCF is implemented for the Choice Based Credit System (CBCS) for the Undergraduate (UG) and Postgraduate (PG) programmes. It focuses on learning, rather than teaching with a student-centred approach. The number of training programmes, workshops, and internal deliberations for the faculty and involvement of employers, alumni and academic experts. help the institution to define the POs, PSOs and COs for respective programmes and courses. The courses are designed aesthetically and then periodically revised according to the changing advancements in the respective fields to make the students more competitive and industry- ready, once they graduate. IQAC organized multiple faculty development programmes on Outcome based Education (OBE) All the faculties of the college were trained in OBE. Based on the training, all courses were designed under OBE paradigm with Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes(CO) specified. The curriculum clearly states Program Outcomes (PO), Program Specific Outcomes (PSO) and Course Outcomes (CO) and teaching-learning pedagogy adapted at the institute. Assessment tools are designed considering the requirements of POs, PSOs and COs. The activities and programs are organized in the Institute to achieve POs, PSOs and COs. At the end of the semester, analysis of PO, PSO, CO attainments is done by each department. The outcomes have been articulated in the college

website. Every faculty explains the course outcomes of each course before the commencement of the same. To integrate OBE all the faculty members are advised to prepare Question Banks based on bloom's taxonomy have been developed. It enables the assessment of the students at cognitive levels namely remembering, understanding, applying, analyzing, evaluating and creating.

20.Distance education/online education:

Various online platforms are used for online seminars and assignments in order to facilitate participatory learning, Google Classroom is used by the teachers as well as the students to teach, create, share and evaluate assignments. Using websites like Canva and Adobe Spark, teachers create visually engaging presentations enhancing student concentration and focus. Students and teaching faculty can access study materials in all the Technologies and Net laboratories. The college library is a DELNET member library, which allows students and faculty to access papers and publications related to their research projects. The college library provides access to E-Resource database such as INFLIBNET, DELNET. Faculty members produce EContents and E-Resources for the students. The curriculum is designed to include MOOCs offered by SWAYAM. Postgraduate students have to take these courses from the second semester onwards. The credits earned from these courses will be treated as extra credits and will be reflected in the mark statements.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses students' learning levels and organises special programmes for both slow and advanced learners.

The college has distinguished itself as a prominent institution, by offering quality teaching-learning to students. For the overall development of students, the institution provides best teachinglearning, which includes a significant number of co-curricular and extracurricular activities. The learning skill of students are assessed and classified as advance and slow learners on the basis of their scoring of entry level marks, continuous internal assessment and end semester examinations. For Advanced learners additional teaching methodologies are adopted and are encouraged to register for SWAYAM, NPTEL, online courses. Group discussion, class room interaction, Editors in departmental Newsletter preparation, to participate and present research articles in the national and international seminars/conferences/workshops/symposia and publish article in reputed journals and book chapter. Programme for the slow learners include remedial classes which are compulsorily to all students below 40% scores. Personal counseling and parents meeting is given to them by the mentors to overcome their personal problem. Remedial classes are conducted to improve their efficiency of examinations, Spoken English classes are conducted on special day orders, glossary, hands-out study materials and question banks are provided. Teachers create and

distribute study materials that are appropriate for slow learners so that they can prepare for End Semester Examinations.

The Office of the Controller of Examinations integrated the Information Technology in the management of Examination System. The Examination pattern consists of two components, namely, Continuous Internal Assessment and End Semester Examination. The performance of the students is assessed for 100 marks in each course through CIA and ESE. Mark entry, Grade, Percentage and Cumulative Grade Point Average, preparation and analysis of results are automated. The appointment orders for examination related duties are issued through e-mail to the concerned faculty. Through the online mode the exam fees were collected. Results are published in the college website and ERP (CLOBAS). Through this app students can view all the notices and circulars pertaining to the matters related to examinations released by the Office of the Controller of Examinations through their mobile phones. Color printed mark sheets with photograph of the students are printed on non-tearable teslin paper which has 13 security features. Examination procedure has been completely automated using COE automation software (eCOE5.0) which maintains student's records in an efficient manner. Students securing minimum 40% marks in CIA along with 75% attendance components are eligible to appear ESE. Project work is made mandatory for all UG and PG students.

RESEARCH, INNOVATIONS AND EXTENSION

3.1 - Promotion of Research and Facilities

3.1.1 - The institution's research facilities are frequently updated and there is a well-defined policy for promotion of research which is uploaded on the institutional website and implemented

The research facilities are regularly augmented. A comprehensive Academic Research Policy was implemented to promote faculty involvement in research and development. This policy encourages higher education, faculty publications, and Ph.D. enrolments, supported by advanced laboratories, central instrumentation facilities, CCSEA approved animal house facility and seed funding for research. As a result, three project proposals were submitted to agencies like SERB, ICMR, and FIST. Additionally, 8 students and 2 faculty members secured grants from TNSCST under the Student Project Scheme, CSIR-HRDG, and DBT-CTEP. The Research Committee enhanced research facilities by organizing workshops, research forums, seminars, and conferences. Faculty achievements include publishing 99 books and chapters, 32 research articles in reputed journals, participating and presenting 302 papers in conferences. The institution has also signed 20 MoUs with academic, governmental, non-governmental, and industrial organizations, fostering active collaboration. To raise awareness about Intellectual Property Rights (IPR), the IPR Cell conducted a fiveday Faculty Development Programme with support from STET Women's College Management. Exclusive sessions are held to cover topics such as identifying intellectual property during innovation, National IPR Policy, Atal Innovation Mission, technology support,

and IPR strategies for startups, highlighting the institution's commitment to fostering research excellence and innovation.

The Entrepreneurship Development (ED) Cell has successfully completed 19 years, fostering a spirit of self-employment and motivating students to become entrepreneurs. The Institution Innovation Council, established under the Ministry of Education (MoE), Government of India, promotes a vibrant innovation ecosystem. The Skill Hub, under Pradhan Mantri Kaushal Vikas Yojana 4.0 by the Ministry of Skill Development & Entrepreneurship, targets training 240 members starting April 2024. On 20.12.2023, the ED Cell conducted hands-on training in "Textile Screen Printing" by Mr. M. Rajavel, Chairman, Raja Screen Printers, Theni, and "Jute Product Making" by Ms. S. Sudha, Jute Bag Skiller, Alangadu. A one-year tailoring course, conducted in partnership with a government-approved institution, benefited 29 students. Certificates were distributed to participants. Additionally, an awareness program on financial assistance schemes and subsidies was held on 29.12.2023, led by Mr. N. Anbalagan, Inspector, District Industries Centre, Thiruvarur. The Incubation

Centre nurtures innovative ideas, receiving proposals from students, some of which were funded by management. Products developed include health mix, herbal hair wash powder, dishwash liquid, phenyl, and biofertilizer. Training on spiral binding was provided on 16.02.2024 and 19.02.2024. STET Bio-Floral Products Development Centre manufactures mushrooms, vermicompost, and micronutrients, generating revenue.

The bio degradable wastes such as plant litters, old newspapers, paper card boards are transported separately to the composting yard, and transformed into organic manures by Vermicomposting and used for garden A project on biotransformation of lignocellulosic wastes into organic manure is undertaken as a continuous process. The vegetable wastes and food wastes generated are collected separately and subjected to compost unit.

The non bio-degradable wastes such as tin, glass, plastics, are sold to the vendors dealing with recycling. The sanitary napkins, and the cotton used in the laboratories are made into ash by using incinerators. The waste water generated in the hostel is treated and used for the purpose of Irrigation of coconut farms.

The biologically contaminated waste materials such as media and microbial culture are sterilized using autoclave, disinfected and disposed in proper labeled disposable bags and disposed in pits and incinerated. The outdated computers are exchanged at the time of upgradation. Other types of e-wastes are collected, stored and disposed off through agents/vendors.

Waste water and Grey water are collected and treated using recycling pit. The chemicals used in the chemistry laboratory are disposed after dilution, collected in choke pits and released. Acids are neutralized and released.

The Office of the Controller of Examinations integrated the Information Technology in the management of Examination System. The Examination pattern consists of two components, namely, Continuous Internal Assessment and End Semester Examination. The performance of the students is assessed for 100 marks in each course through CIA and ESE. Mark entry, Grade, Percentage and Cumulative Grade Point Average, preparation and analysis of results are automated. The appointment orders for examination related duties are issued through e-mail to the concerned faculty. Through the online mode the exam fees were collected. Results are published in the college website and ERP (CLOBAS). Through this app students can view all the notices and circulars pertaining to the matters related to examinations released by the Office of the Controller of Examinations through their mobile phones. Color printed mark sheets with photograph of the students are printed on non-tearable teslin paper which has 13 security features. Examination procedure has been completely automated using COE automation software (eCOE5.0) which maintains student's records in an efficient manner. Students securing minimum 40% marks in CIA along with 75% attendance components are eligible to appear ESE. Project

work is made mandatory for all UG and PG students.

RESEARCH, INNOVATIONS AND EXTENSION

3.1 - Promotion of Research and Facilities

3.1.1 - The institution's research facilities are frequently updated and there is a well-defined policy for promotion of research which is uploaded on the institutional website and implemented

The research facilities are regularly augmented. A comprehensive Academic Research Policy was implemented to promote faculty involvement in research and development. This policy encourages higher education, faculty publications, and Ph.D. enrolments, supported by advanced laboratories, central instrumentation facilities, CCSEA approved animal house facility and seed funding for research. As a result, three project proposals were submitted to agencies like SERB, ICMR, and FIST. Additionally, 8 students and 2 faculty members secured grants from TNSCST under the Student Project Scheme, CSIR-HRDG, and DBT-CTEP. The Research Committee enhanced research facilities by organizing workshops, research forums, seminars, and conferences. Faculty achievements include publishing 99 books and chapters, 32 research articles in reputed journals, participating and presenting 302 papers in conferences. The institution has also signed 20 MoUs with academic, governmental, non-governmental, and industrial organizations, fostering active collaboration. To raise awareness about Intellectual Property Rights (IPR), the IPR Cell conducted a five-day Faculty Development Programme with support from STET Women's College Management. Exclusive

sessions are held to cover topics such as identifying intellectual property during innovation, National IPR Policy, Atal Innovation Mission, technology support, and IPR strategies for startups, highlighting the institution's commitment to fostering research excellence and innovation.

3.3 - Innovation Ecosystem

3.3.1 - Institution has created an ecosystem for innovations and creation and transfer of knowledge supported by dedicated centres for research, entrepreneurship, community orientation, incubation, etc.

The Entrepreneurship Development (ED) Cell has successfully completed 19 years, fostering a spirit of self-employment and motivating students to become entrepreneurs. The Institution Innovation Council, established under the Ministry of Education (MoE), Government of India, promotes a vibrant innovation ecosystem. The Skill Hub, under Pradhan Mantri Kaushal Vikas Yojana 4.0 by the Ministry of Skill Development & Entrepreneurship, targets training 240 members starting April 2024. On 20.12.2023, the ED Cell conducted hands-on training in "Textile Screen Printing" by Mr. M. Rajavel, Chairman, Raja Screen Printers, Theni, and "Jute Product Making" by Ms. S. Sudha, Jute Bag Skiller, Alangadu. A one-year tailoring course, conducted in partnership with a government-approved institution, benefited 29 students. Certificates were distributed to participants. Additionally, an awareness program on financial assistance schemes and subsidies was held on 29.12.2023, led by Mr. N. Anbalagan, Inspector, District

Industries Centre, Thiruvarur. The Incubation Centre nurtures innovative ideas, receiving proposals from students, some of which were funded by management. Products developed include health mix, herbal hair wash powder, dishwash liquid, phenyl, and biofertilizer. Training on spiral binding was provided on 16.02.2024 and 19.02.2024. STET Bio-Floral Products Development Centre manufactures mushrooms, vermicompost, and micronutrients, generating revenue.

Community outreach programs, organized in collaboration with governmental and non-governmental organizations, address grassroots-level issues, enhancing student involvement in societal development and community welfare.

7.1.3 - Describe the facilities in the institution for the management of the following types of degradable and non-degradable waste (within a maximum of 200 words)

The bio degradable wastes such as plant litters, old newspapers, paper card boards are transported separately to the composting yard, and transformed into organic manures by Vermicomposting and used for garden A project on biotransformation of lignocellulosic wastes into organic manure is undertaken as a continuous process. The vegetable wastes and food wastes generated are collected separately and subjected to compost unit.

The non bio-degradable wastes such as tin, glass, plastics, are sold to the vendors dealing with recycling. The sanitary napkins, and the cotton used in the laboratories are made into ash by using incinerators. The waste water generated in the hostel is treated and used for the purpose of Irrigation of coconut farms.

The biologically contaminated waste materials such as media and

microbial culture are sterilized using autoclave, disinfected and disposed in proper labeled disposable bags and disposed in pits and incinerated. The outdated computers are exchanged at the time of upgradation. Other types of e-wastes are collected, stored and disposed off through agents/vendors.

Waste water and Grey water are collected and treated using recycling pit. The chemicals used in the chemistry laboratory are disposed after dilution, collected in choke pits and released. Acids are neutralized and released.
